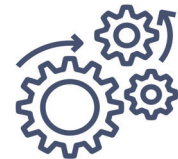
### Incoming Mail Handling

### Document Scanning & Indexing

Utilizing state-of-the-art document scanners, we will do all the prepping, scanning, indexing, and quality control needed to ensure the highest document image quality. We provide automatic document classification and optical character recognition (OCR) capabilities if you need to automatically extract data from your documents.



### Workflow & Distribution

Once released from QC, your document images will be merged with any other incoming electronic files and routed via workflow automation software to the right personnel based on business rules.

**PICK UP**  
We can handle daily pickups of mail at the outlined locations (PO Box, office locations, etc.).

**MAIL SORTING**  
We will process all the delivered mail and exclude pieces of mail based on the rules and guidelines set by the client. These guidelines will also identify which pieces of mail will be sent back to the client.



**DOCUMENT PREPARATION**  
Each processed piece of mail will be scanned and indexed based on the client's specifications.

**ECM SYSTEM INTEGRATION**  
If the client has an enterprise content management (ECM) system, each scanned document will be entered into it for workflow processing.

**RECORD RETURN OR DISPOSAL**  
Based on client preference, the documents will either be sent back to the client, kept in storage, or professionally destroyed with a Certificate of Destruction provided to the client.
